Dr. Jeffrey Gold, University of Nebraska President, welcomed the Commissioners to the UNL campus and gave a brief overview of his first ten weeks as NU President.

Public Institutions Biennial Budget Presentations

Chair Von Behren

PUBLIC INSTITUTIONS BIENNIAL BUDGET PRESENTATIONS

Chair Von Behren welcomed and introduced representatives from the public institutions to present their biennial budget requests.

University of Nebraska

President Dr. Gold addressed the Commissioners and presented the University of Nebraska's biennial budget request. The University is requesting a funding increase of \$1.5 million per each year of the biennium to match the Board of Regents' investment on expanding the new Presidential Scholars Program, \$1.5 million to support the Nebraska Research Initiative, 3% each year for salaries, and 5% health insurance costs.

Dr. Paul Turman, Nebraska State College System

Nebraska State College System

Chancellor Dr. Paul Turman stated the NSCS is requesting a 3% increase for salaries, 5% for health insurance and funding for operating costs, and core needs. Additional funding is requested for the Career Scholarship fund and the Rural Health Opportunities Program (RHOP) Scholarships. Dr. Turman stated a strategy to complete several capital construction projects at the state institutions is listed in the budget request.

Dr. Matt Gotschall, Nebraska Community College Association

Nebraska Community College Association

President Dr. Matt Gotschall, President, Central Community College, presented a PowerPoint presentation, stating the community colleges are requesting a \$13.9 million increase from 2024-25 of which an additional \$10 million is for dual enrollment to help offset the loss of \$5 million in ARPA funds.

President Randy Schmailzl, Metropolitan Community College

Metropolitan Community College

President Randy Schmailzl discussed the budget request that President Gotschall presented, adding Metropolitan Community College offers around 35 percent of the state's dual enrollment classes. They work with UNO on credit transfer, and all the high school districts helping teachers get qualified to teach dual enrollment classes. He noted that MCC has an enrollment of 27,000 students, with 70 percent attending part-time.

2024 Tuition, Fees, and College Affordability Report

Mr. Morrow presented the report and stated that this report is required by statute and due to the Governor and Appropriations Committee by October 1 of each even-numbered year. Mr. Morrow gave a brief overview of tuition and fees, cost of attendance, net price of attendance, student payment share, and the state's investment in higher education. The report provides graphs showing state and local appropriations per FTE and includes policy and budgetary recommendations to maintain Nebraska's competitive position on tuition and fees and to improve affordability for all students. The report concludes with a review a Nebraska's public postsecondary institutions and how they compare to their peer institutions.

Access College Early (ACE) Scholarship 2023-24 Year-End Report

Mr. Morrow presented the report stating that ACE scholarships pay tuition and mandatory fees of eligible low-income Nebraska high school students taking dual-enrollment and early-admit college courses at participating Nebraska colleges and universities. For 2023-2024, the ACE program was funded with \$1.5 million dollars general funds appropriated by the Legislature. There were 2,627 students from 192 high schools that received 5,584 scholarships. The total awarded was \$1,110,314.55 with the average award per scholarship equaling \$199.12.

Mr. Morrow reviewed graphs on scholarships awarded, credit hours taken, eligibility, and gender and race/ethnicity of recipients. He spoke on college continuation rates, noting ACE students are doing very well going on to college. The ACE report includes each college, the amount awarded, number of students, scholarships, and average amount of each scholarship per college.

Mr. Morrow presented the report, commenting that Nebraska ranked 31st in the country for need-based undergraduate grant dollars per undergraduate enrollment in 2021-22. In the 2023-24 award year, \$24,416,073 was awarded to 13,507 students with the average award being \$1,807.66. He gave an overview of the NOG awarding by source, sector, and family income over the past 10 years.

CCPE Biennial Budget Request for 2025-27

Gary Timm presented the Budget Request

CCPE Biennial Budget Request for 2025-27

Gary Timm, Chief Finance Officer, reported that the CCPE agency budget is due to the DAS-Budget Division on September 15, 2024. The request is broken down into two categories: Financial Aid and Operating Funds. He stated the CCPE is requesting an increase in NOG funds of \$1 million of General funds and \$500,000 of lottery funds for the first year of the biennium and an additional \$1 million of General Funds the second year of the biennium. Based on current average awards, each \$1 million increase would provide funding for approximately 550 students. Also included in the request were increases to the aid amounts for the Excellence In Teaching Program.

Mr. Timm reviewed the Administrative Funds request for a 3 percent annual increase for staff salaries and a 5 percent increase in employee health plan costs each year of the biennium, along with increases for travel costs and certain operating expenses.
