## Pillar Seminary Application to Establish an Administrative Office Narrative Responses

## Questions 1:

We have attached 3 years of financial statements in a separate document. Our tuition for each semester is a flat rate of \$2500 per semester. Our annual budget is approximately attached in a separate excel file. If Pillar were to discontinue operations, we would work with each individual student to help them find another institution that would accept their credits to transfer. We currently do not have a teach out agreement as we need to be accredited to have one. That is our priority after accreditation is received. We currently do not work with any loans; all our students are either self-funded and/or receive a scholarship.

## Question 2:

We currently have 4 instructors Bishop Donnell Moore, Dr. Dan Lowery, Dr. Scott Booth, and Dr. Beth Currier. I have attached their CVs or bios. We are currently working to an agreement for online library services. We Bishop Moore, Dr. Booth, and Dr. Lowery all currently work individually with students regarding career advising. LaRhesa Mays has recently moved into the role of Director of Student Services and does an amazing job working with students are their academic advisor.

## Question 3:

We offer three programs, each of which is designed to advance the abilities of ministry leaders progressively and profoundly in Bible and Leadership. The programs build on one another; that is, all credits from one program can be applied to the next. This allows students to set goals and easily transition from one program to another. (Credits can only be applied to one degree.) They are: Certificate in Contextual Leadership (11 Credits), Master of Arts in Contextual Leadership (47 Credits), Master of Divinity (74 Credits). We have attached a File that runs through the credit requirements and classes for each option.

Due to the varied nature of religions that use The Bible as their basis we currently do not offer any individual licensure or certificates. Some sects require particular licensure or certificates and routinely work with students to help them determine the best way to achieve them. We do not require any clinical placement for our programs. The relationship to credit hours and hour of instruction is two credit hours per one hour of instruction.

## Question 4:

We are a full online seminary with professors and students around the country and the world. Although we are based out of Omaha, we closed our physical offices due to and at the beginning of the COVID-19 pandemic. We currently operate an administrative office out of our registered agent's office. We do not have a lease for this as it is donated to Pillar by the Director of Finance and Operations who owns and works out of the location.

## Question 5:

We currently do not have any articulation agreements with any other Nebraska institutions. We are currently discussing them with outside Nebraska organizations, however receiving accreditation is a requirement. We do however work with any student who approaches us along with the school they want to transfer to facilitate transferring credits.

## Question 6:

We have applied for accreditation with Distance Education Accrediting Commission. We are currently awaiting verification of application and will pass that verification along when received. One of the requirements for accreditation is obtaining a state license. This process can take between 1.5 and 2.5 years.

## Question 7:

The first requirement for admissions is involvement in ministry. Priority in admissions is given to applicants in active full- or part-time ministry. Prospective students involved in volunteer ministry are valued, welcome, and encouraged as well. A baccalaureate degree is strongly preferred, but not required. An applicant for admission into the MDiv or MA program who does not have a baccalaureate degree, but who meets all other admissions requirements, or an applicant possessing a baccalaureate degree from an unaccredited institution, will receive provisional admission. After completing one year of study (Biblical Narrative 1-2 and Introduction to Contextual Biblical Leadership), and having an interview with a faculty member, the provisional admission may be removed after the student has demonstrated ability to do acceptable graduate work in individual and classroom settings.

Students who are accepted into The Pillar Seminary are given either Full, Provisional, or Conditional acceptance. Full acceptance is admission without further requirements. Provisional acceptance may be granted either in cases where the applicant still needs to submit final official transcripts with graduation date, or students who do not have an accredited baccalaureate degree. Conditional Acceptance may be given to applicants who have been admitted and have special conditions placed on their acceptance and may be denied registration or be subject to possible withdrawal from school if conditions are not met.

We currently use Facebook, a podcast, and seminars for recruiting, as well as word of mouth. We do not offer or discuss loans with current or potential students.

## Question 8:

Students may withdraw from a semester up to three weeks after the first day of the Fall or Spring semester without penalty. Students who withdraw from a semester four to six weeks after the first day of the Fall or Spring semester forfeit fifty percent of their tuition. Any student wishing to withdraw after six weeks forfeits their full tuition.
