Military initiative gains momentum

The Coordinating Commission organized a meeting recently of Nebraska stakeholders in a multi-state initiative to help military members, veterans and their families earn college credit and enter the workforce.

The Commission is leading Nebraska's efforts as part of the Multi-State Collaborative on Military Credit. Thirteen Midwestern states are participating in the initiative, which is administered by the Midwestern Higher Education Compact and funded through a grant from the Lumina Foundation.



Dr. Kathleen Fimple, the Commission's Academic Programs Officer, facilitated the Nebraska meeting, held Nov. 19 at Central Community College. More than 20 people attended, representing postsecondary institutions, the Nebraska Department of Education, the Legislature, U.S. Department of Veterans Affairs, and business leaders.

CCPE leads the way in state FAFSA effort

ing an effort in Nebraska to encourage more high school students to apply for federal financial aid to attend college.

As part of the U.S. Department of Education's new FAFSA Completion Initiative, the Commission can provide certain designated entities - typically high schools - with limited data about students' progress in completing and filing the Free Application for Federal Student

The Coordinating Commission is lead- Aid (FAFSA). The timely completion of a FAFSA is an essential step for many families in obtaining financial aid. The U.S. Department of Education reports that less than 55 percent of seniors complete the FAFSA. Meanwhile, studies show a 25-30 percent increase in the likelihood of low-income students starting college if they complete the FAFSA.

> The FAFSA Initiative will enable the designated entities to better target

counseling, filing help, and other resources to those students. Identifying such students can promote college access and success by ensuring students, particularly low-income students, have access to financial aid.

The Commission received funding from the Legislature in 2015 for the implementation of the initiative's software. More information on the initiative is available on the Commission website.

Commission releases annual reports on financial aid programs

The Commission's Financial Aid Officer, J. Ritchie Morrow, presented year-end reports for the Access College Early (ACE) and Nebraska Opportunity Grant (NOG) scholarship programs at the Dec. 3 CCPE meeting. ACE pays for low-income high school students to take dual-credit courses; NOG provides financial aid to low-income Nebraska college students. Below are highlights from each.

ACE (2014-15)

Total funds awarded: \$953,596 (\$681,706 General funds;

\$271,890 federal grant)

Students: 1,919

High schools represented: 211

Scholarships awarded: 4,082 (students can receive multiple

scholarships to pay for multiple courses) Average scholarship award: \$233.67

Students who earned a B or better in ACE course: 76%

NOG (2014-15)

Total funds: \$16.4 million (\$9.5 million Lottery funds;

\$6.9 million General funds)

Students: 15,943

Students by sector: 41% community college; 24% NU; 19% independents; 9% private career schools; 7% State Colleges

Average grant: \$1,032

Students who qualified but did not receive a grant due to lack

of funds: Roughly 30,000

RESEARCH SPOTLIGHT:

DATA DASHBOARDS

The Coordinating Commission is the only entity in Nebraska that conducts in-depth, statewide analyses of higher education issues. As part of that work, the Commission recently posted on its website two interactive data dashboards.

One dashboard features data on college continuation rates in Nebraska, while the other focuses on the information presented in the Degrees and Other Awards section of the 2015 Factual Look at Higher Education in Nebraska.
